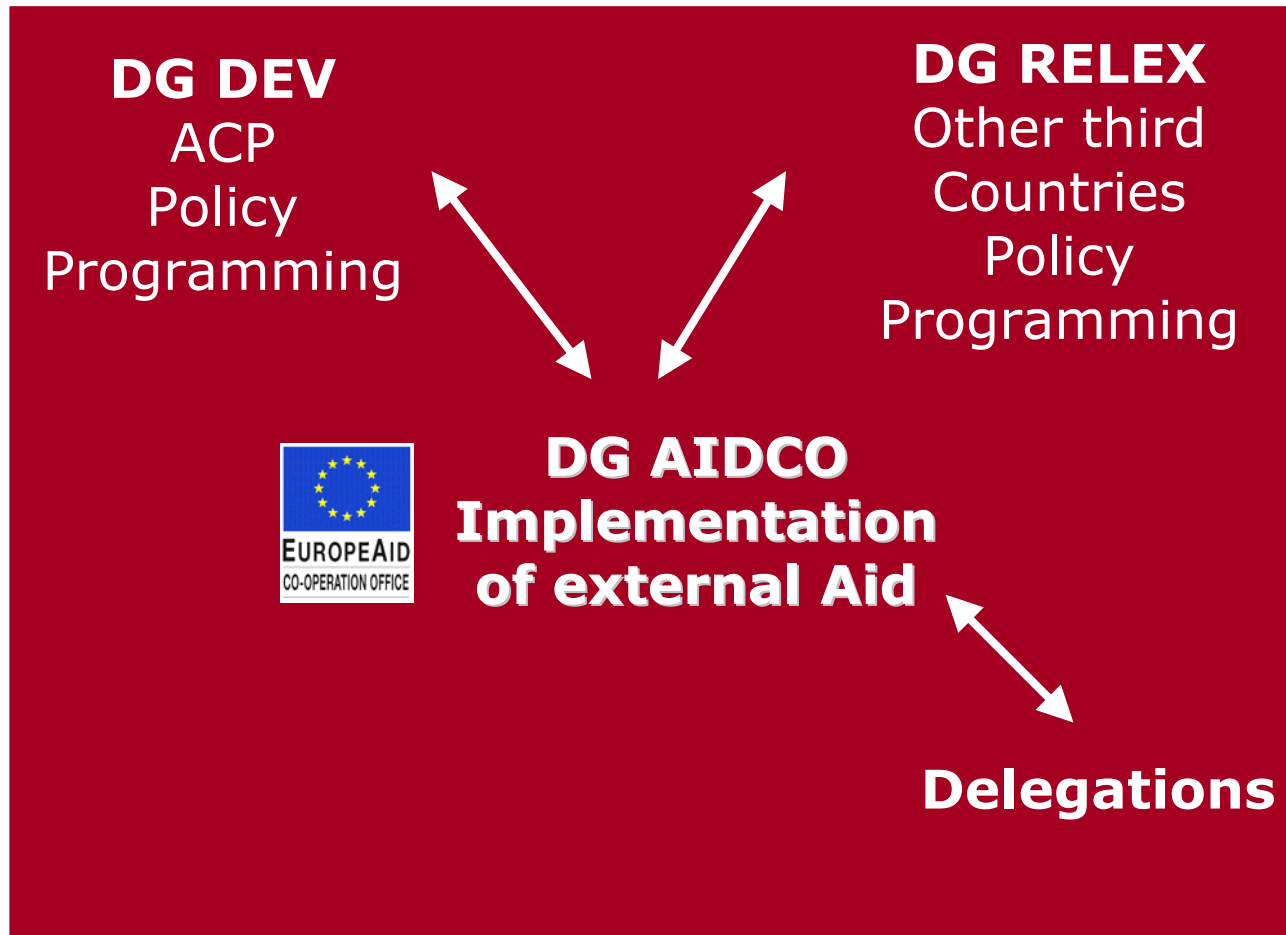

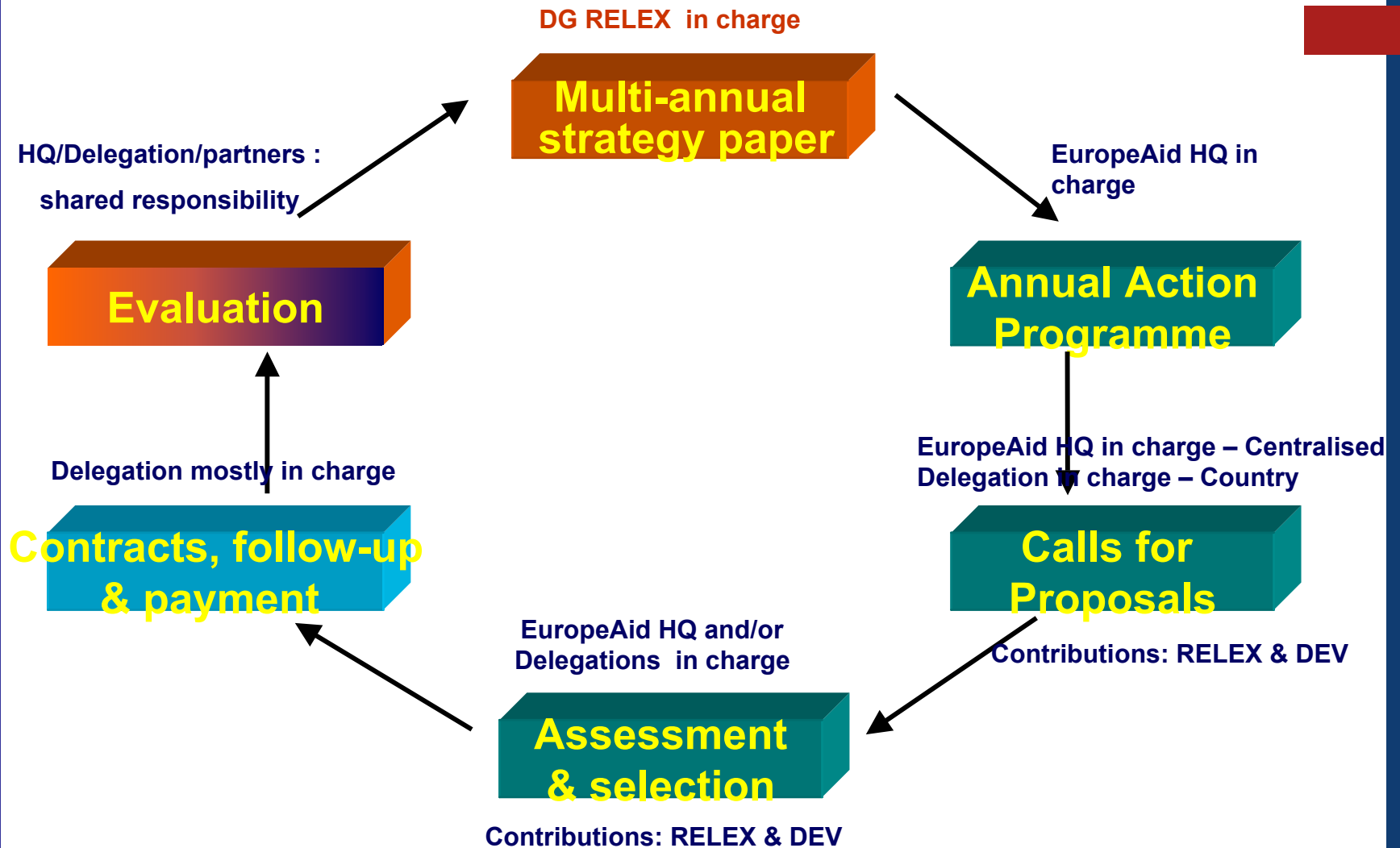

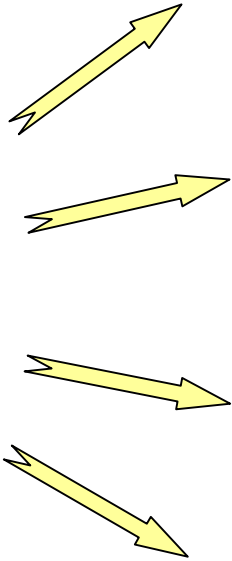
PROJECT CYCLE

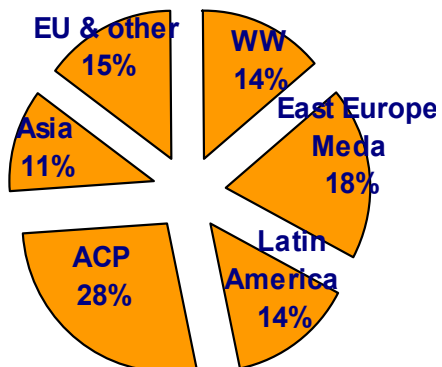

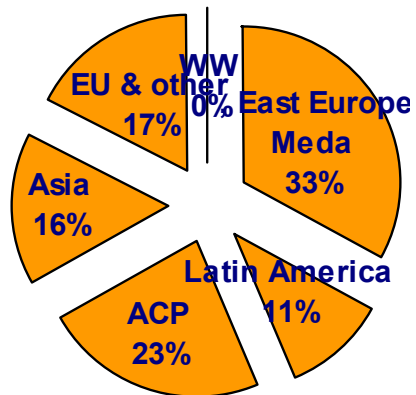

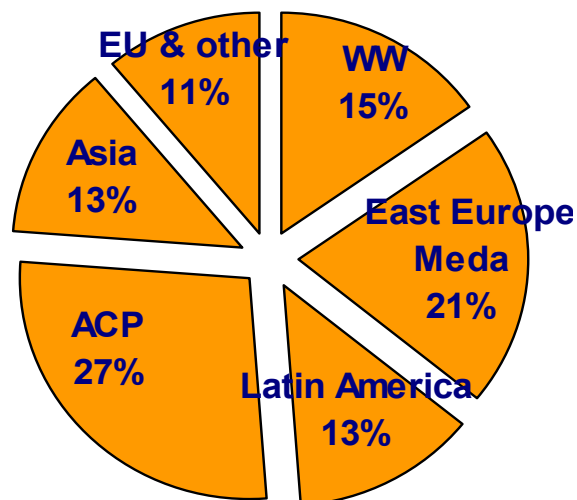

- ◆ A financial and policy instrument contributing to the development and consolidation of democracy and the rule of law, and of respect of all human rights and fundamental freedoms in third countries world-wide
- ◆ Cooperation with civil society organisations and international organisations around the world – no prior consent of the host government required
- ◆ Initiative of the European Parliament (1994)
- ◆ First legal basis = Council regulations 975/99 and 976/99 (amended in December 2004)

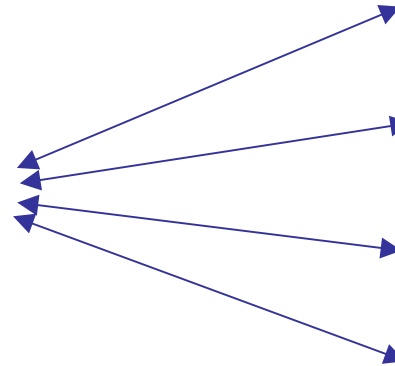

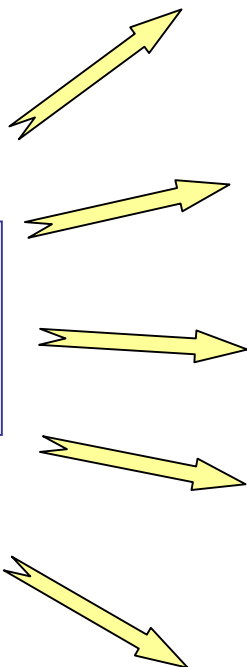

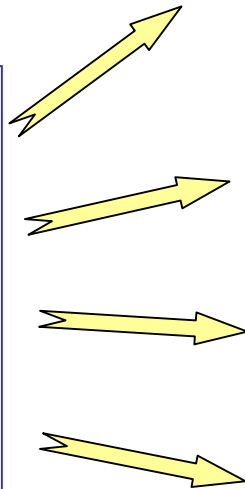

Eligibility of organisations (Article 10 of the Regulation)

- **Specific to each call for proposals**
- **Civil society organisations (NGOs, independent political foundations, private sector non-profit agencies...)**
- **Public sector non-profit agencies, institutions, ...**
- **Parliamentary bodies, when necessary**
- **International inter-governmental organisations**
- **Natural persons**
