Dear Foreign Secretary,

We are deeply concerned to hear the government intends to cut fundamental elements of UK aid – namely, funding for health, preventing and responding to conflict and tackling the climate emergency. The crisis in Ukraine is a humanitarian tragedy with significant geopolitical consequences, and the FCDO is right to respond. However, the significance of this crisis demonstrates the importance of having a bold and ambitious International Development Strategy that is poverty-focused, evidence and rights-based, and accountable to the British public and communities it is meant to serve.

The Government's own strategy states the UK's global reputation and influence is dependent on the "three Ds" of defence, diplomacy and development. It now risks undermining its own effectiveness by rowing back on development. It would be short-sighted to drop critical issues like global health, climate change and conflict prevention from the forthcoming International Development Strategy. It would also cost lives. These are areas where the UK has a strong track record of impact and significant expertise and this move will undermine the UK's ability to play our part globally in tackling urgent challenges, increasing security, and eradicating poverty. Supporting countries in times of crisis is critically important, but so too is investing in the development assistance that prevents these crises.

Looming famines in Afghanistan, Yemen, and the Horn of Africa – exacerbated by global food price hikes as a result of the crisis in Ukraine – and the devastation caused by Covid-19 and climate change should be a reminder of how intrinsically linked we all are, and that no-one is safe until we all are. Now more than ever, it is essential the UK's aid budget be spent in ways that maximise the UK's ability to respond to and prevent crises. Withdrawing funding from one crisis to pay for another simply displaces the problem and ultimately does not reduce the costs. The right decision would be to restore the UK's 0.7% GNI on Official Development Assistance (ODA) commitment.

Since 1974, the UK has committed to supporting people in times of crisis: providing vaccines and other health services to marginalised communities, investing in peacebuilding to prevent conflict and investing in communities so they can adapt to avoid the most devastating consequences of climate change. By honouring our promises to lower-income countries and communities, we demonstrate that we are a country that provides solutions and plays its part in the world. We cannot do that if we abandon development.
