



Joint statement from UK INGO sector to the new Prime Minister

As 104 leaders of UK NGOs working on international development, humanitarian assistance, peacebuilding, and tackling the climate crisis, we are calling on your new government to confront the underlying drivers of inequality, injustice and poverty that affect people both here in the UK and around the world. Politicians must stop pitting the needs of the British public against the needs of people in the Majority World by raiding the already diminished UK aid budget to fund domestic spending. Both face many of the same underlying challenges. Whether it is increasing living costs or growing inequality, the same unfair global economic system is failing ordinary people everywhere, and this is where you can make real change.

Prime Minister, you have an opportunity to tackle the root causes of poverty and inequality and promote solidarity across marginalised communities both here in the UK and internationally. Your emphasis on reshaping our economic and political systems, and bringing greater power at local level to better address the needs of ordinary people, promises to take us in this direction. We welcome this.

However, your decision to reallocate £400 million of the UK's international climate finance to help fund a cap on bus fares in the UK risks pitting the needs of marginalised people in lower-income and climate vulnerable countries against those in the UK. Diverting resources away from quality grant funding for those who need it most leaves countries already trapped in unfair debt cycles with few choices but to borrow more, to address a climate crisis not of their making.

Your government does not have to choose between helping families in the UK through the cost-of-living crisis or tackling the climate crisis and fighting extreme poverty globally. Framing these challenges as competing priorities is a mistake. The real challenge, and the real opportunity, is to address their common causes. Fairly taxing the wealthiest and largest polluters in society would generate tens of billions a year in public finance to increase international commitments and domestic action. Coupled with ambitious leadership for the UK's upcoming G20 presidency to reform the global economic system, this would help deliver greater fairness, opportunity and prosperity for ordinary people both at home and abroad. By protecting what remains of the UK aid budget, reversing recent international climate finance cuts, and setting out a roadmap for returning UK aid spending to 0.7% of GNI, you can restore the UK's credibility as a reliable global partner.

The decisions you make now will impact lives and the climate for decades to come. We urge you to take the spirit of Manchesterism to the world by tackling global challenges that hold back local progress. Let's seize this moment to build a more just, resilient and sustainable future for us all.
